OHIO ATHLETIC COMMISSION

Minutes of the April 14, 2015 meeting of the Ohio Athletic Commission ("OAC") held at 10:00 A.M. at the Bureau of Workers' Compensation, Garfield Heights, Ohio.

I. The meeting was called to order at 10:00 a.m. The Pledge of Allegiance was led by Executive Director Bernie Profato. Roll call was taken by Mr. Profato. Present for roll call were: Commissioner Tim Ochsenhirt, Commissioner Robert Schuerger, Commissioner Jon Stainbrook, Commissioner Terry Patton and Commissioner Dr. Armile.

II. The minutes of the March 10, 2015 meeting were first on the agenda. Commissioner Dr. Armile moved to approve the minutes. Commissioner Stainbrook seconded the motion and it was unanimously approved.

The Licensure list was presented for Commission approval. Commissioner Schuerger moved to approve the list. Commissioner Stainbrook seconded the motion and it was unanimously approved.

III. Under unfinished business Mr. Profato stated that the Financial Disclosure statements are due April 15th. If they are not submitted on time, the Commission will get fined.

IV. Under new business, Mr. Profato stated that he will send Promoters Nate Tubbs and Greg Kalikas suspension letters with a notice of opportunity for a hearing. Each Promoter will have thirty days to request a hearing. Nate Tubbs missed the 72 hour deadline for submitting fees owed to the state of Ohio. Mr. Profato received complaints from two boxers for not being paid. Greg Kalikas also missed the 72 hour deadline and bounced a second check. However, as of April 13th the check was made good.

V. A Pro Am MMA event that was scheduled for Findlay on April 18, promoted by Scott Sheeley was cancelled on April 13.

A Pro Boxing event in Campbell is scheduled on April 18, promoted by John Loew. Commissioner Stainbrook moved to approve the event. Commissioner Dr. Armile seconded it and it was unanimously approved.

A Pro Boxing event in Toledo is scheduled on May 8, promoted by Fred Vallejo.

Commissioner Schuerger moved to approve the event. Commissioner Stainbrook seconded it and it was unanimously approved.

VI. The Executive Director's report was read by all of the Commissioners.

VII. There were no public comments.

VIII. Commissioner Dr. Armile moved to adjourn. Commissioner Schuerger seconded the motion, and it was unanimously approved.
