OHIO ATHLETIC COMMISSION

Minutes of the September 8, 2015 meeting of the Ohio Athletic Commission ("OAC") held at 10:00 A.M. at the Bureau of Workers' Compensation, Garfield Heights, Ohio.

- I. The meeting was called to order at 10:00 a.m. The Pledge of Allegiance was led by Executive Director Bernie Profato. Roll call was taken by Mr. Profato. Present for roll call were: Commissioner Stainbrook, Commissioner Patton and Commissioner Dr. Armile.
- II. The minutes of the August 11, 2015 meeting were first on the agenda. Commissioner Patton moved to approve the minutes. Commissioner Dr. Armile seconded the motion and it was unanimously approved.  
  
The Licensure list was presented for Commission approval. Commissioner Dr. Armile moved to approve the list. Commissioner Stainbrook seconded the motion and it was unanimously approved.
- III. Under unfinished business Mr. Profato stated that the representative from B's Buzz Boxing from Las Vegas did not show up today for the Commission meeting. She called the office this morning and was told she can come to the November 10<sup>th</sup> Commission meeting and show proof of the group's financial stability and detail their plans for promoting in Ohio.
- IV. Under new business Mr. Profato discussed the cancellation of Promoter Joe Bridenbaugh's September 26<sup>th</sup> Pro/Am MMA show because of 4 illegal title fights at his last event. The title fights were not cleared with the Commission. None of the fighters met Ohio's standards. Mr. Profato told him he could come before the Commission for a hearing or cancel his next show. He decided to cancel his show. He sent an email and admitted he was wrong and would not do it again.
- V. A Pro Boxing event in Columbus on September 24 promoted by Alice Speakman. Commissioner Patton moved to approve the event. Commissioner Dr. Armile seconded it and it was unanimously approved.  
  
A Pro Am MMA event in Lima on September 26 promoted by Scott Sheeley. Commissioner Dr. Armile moved to approve the event. Commissioner Patton seconded it and it was unanimously approved.

A Pro Boxing event in Cincinnati on October 3 promoted by Leon Margules. Commissioner Patton moved to approve the event. Commissioner Dr. Armile seconded it and it was unanimously approved.

- VI. The Executive Director's report was read by all of the Commissioners. Commissioner Dr. Armile moved to accept the Executive Director's report. Commissioner Patton seconded it and it was unanimously approved.
- VII. There were no public comments.
- VIII. Commissioner Patton moved to adjourn. Commissioner Dr. Armile seconded the motion, and it was unanimously approved.
