**OHIO ATHLETIC COMMISSION**

Minutes of the July 11, 2012 meeting of the Ohio Athletic Commission ("OAC") held at 10:00 A.M. at the Bureau of Workers' Compensation, Garfield Heights, Ohio.

- I. The meeting was called to order at 10:00 a.m. The Pledge of Allegiance was led by Executive Director Bernie Profato. Roll call was taken by Executive Director Profato. Present for roll call were: Commissioner John Konstantinos, Commissioner Robert Schuerger, Commissioner Dr. Harry Stiggers and Commissioner Tim Ochsenhirt.
- II.
  - A. The minutes of the June 13, 2012 meeting were first on the agenda. Commissioner Tim Ochsenhirt moved to approve the minutes. Commissioner Dr. Stiggers seconded the motion and it was unanimously approved.
  - B. The Licensure list was presented for Commission approval. Commissioner Tim Ochsenhirt moved to approve the list. Commissioner Dr. Stiggers seconded the motion and it was unanimously approved.
- III. Under unfinished business, Mr. Profato stated that he sent the material that was taken from the Second who was working the boxing show in Columbus to the Youngstown State University lab. The stuff has so much junk in it that the YSU lab cannot figure it out. Rather than sending the cream to the BCI and waiting six months for an answer Mr. Profato will send the Second a letter telling him that he is suspended. If he wants to appeal then he can have a hearing and explain what is in the cream.
- IV. Under new business, Mr. Profato stated that he worked with the FBI on the Boxing match in Toledo. The FBI was investigating DNA evidence from a bank robbery in which a teller was shot. We were legally allowed to get the hand wraps afterwards from the fighter. We examined the hand wraps of this fighter and three other fighters. The FBI came down after the fight and confiscated the hand wraps which also contained blood from the fighter's nosebleed. They now have enough evidence from the hand wraps and can issue a search warrant to draw the DNA.
- V. A Pro Boxing event in Cincinnati on July 21, promoted by Golden Boy Promotions; Commissioner Dr. Stiggers moved to approve the event. Commissioner Schuerger seconded it and it was unanimously approved.

A Pro Boxing event in Columbus on July 21, promoted by Alice Speakman; Commissioner Dr. Stiggers moved to approve the event. Commissioner Robert Schuerger seconded it and it was unanimously approved.

A Pro Am MMA event in Columbus on August 4, promoted by Jason Percell; Commissioner Tim Ochsenhirt moved to approve the event. Commissioner Dr. Stiggers seconded it and it was unanimously approved.

A Pro Am MMA event in Eastlake on August 4, promoted by Greg Kalikas; Commissioner Dr. Stiggers moved to approve the event. Commissioner Tim Ochsenhirt seconded it and it was unanimously approved.

- VI. The Executive Director's report was read by all of the Commissioners.
- VII. There were no public comments.
- VIII. Commissioner Dr. Stiggers moved to adjourn the meeting. Commissioner Robert Schuerger seconded the motion, and it was unanimously approved.
