**OHIO ATHLETIC COMMISSION**

Minutes of the December 13, 2016 meeting of the Ohio Athletic Commission ("OAC") held at 10:00 A.M. at the Bureau of Workers' Compensation, Garfield Heights, Ohio.

- I. The meeting was called to order at 10:00 a.m. The Pledge of Allegiance was led by Executive Director Bernie Profato. Roll call was taken by Mr. Profato. Present for roll call were: Commissioner Schuerger, Commissioner Stainbrook, Commissioner Mancini and Commissioner Dr. Armile.
- II. The minutes of the November 8, 2016 meeting were first on the agenda. Commissioner Dr. Armile moved to approve the minutes. Commissioner Stainbrook seconded the motion and it was unanimously approved.
