OHIO ATHLETIC COMMISSION

Minutes of the May 10, 2016 meeting of the Ohio Athletic Commission ("OAC") held at 10:00 A.M. at the Bureau of Workers' Compensation, Garfield Heights, Ohio.

- I. The meeting was called to order at 10:00 a.m. The Pledge of Allegiance was led by Executive Director Bernie Profato. Mr. Profato welcomed Ray Mancini as the Commission's newest member. Mr. Mancini is a former World Lightweight Champion and International Boxing Hall of Fame member. Commissioner Terry Patton was reappointed to another term. Roll call was taken by Mr. Profato. Present for roll call were: Commissioner Stainbrook, Commissioner Patton, Commissioner Dr. Armile, and Commissioner Mancini. Commissioner Schuerger was absent and Commissioner Stainbrook acted as Chairman.
- II. The minutes of the April 12, 2016 meeting were first on the agenda. Commissioner Dr. Armile moved to approve the minutes. Commissioner Patton seconded the motion and it was unanimously approved with Commissioner Mancini abstaining.

The Licensure list was presented for Commission approval. Commissioner Patton moved to approve the Licensure list. Commissioner Dr. Armile seconded the motion and it was unanimously approved.
- III. Under unfinished business Mr. Profato discussed the Promoter Background Information sheet and thanked everyone for their input. Commissioner Armile made a motion to incorporate into the application process the Promoter Background Information sheet. Commissioner Patton seconded the motion and it was unanimously approved.
- IV. Under new business Mr. Profato discussed the debut fighter policy. The MMA matchmakers need to do a better job of evaluating debut fighters. They need to ask the fighter how long they have been training and where they have been training. For boxers there is currently no amateur database. If a debut fighter does not have his passbook there is no way to know his record.

Also under new business Mr. Profato discussed the Office of Information Technology report recommendations. The Athletic Commission office will be getting three new computers.

V. A Pro Am MMA event on May 14 in Columbus promoted by Troy Speakman. Commissioner Patton moved to approve the event. Commissioner Dr. Armile seconded the motion and it was unanimously approved.

A Pro Am MMA event in Toledo on May 20 promoted by Jose Martinez. Commissioner Dr. Armile moved to approve the event. Commissioner Patton seconded the motion and it was unanimously approved.

A Pro Boxing event in Maumee on May 21 promoted by Fred Vallejo. Commissioner Patton moved to approve the event. Commissioner Dr. Armile seconded it and it was unanimously approved.

A Pro Boxing event in Columbus on June 10 promoted by Troy Speakman. Commissioner Mancini moved to approve the event. Commissioner Patton seconded it and it was unanimously approved.

A Pro Am MMA event in Akron on June 11 promoted by Dannon Svab. Commissioner Armile moved to approve the event. Commissioner Mancini seconded it and it was unanimously approved.

VI. The Executive Director's Report was read by all of the Commissioners.

VII. There were no public comments.

VIII. Commissioner Patton moved to adjourn. Commissioner Dr. Armile seconded the motion, and it was unanimously approved.
